A. INTRODUCTION: The Writer, the Readers, and the Good News (Romans 1:1-17).

B. CONDEMNATION: The Unveiling of God's Wrath against Man's Unrighteousness 1:18 - 3:20

- 1. The Condemnation of Gentiles 1:18-32. (The term Gentiles refers to non Jewish people in the world.)
 - a. The Constant Unveiling of God's Wrath. 1:18. (The word *revealed* means literally, *unveiled*.)
 - 1) What is God angry against?
 - 2) What truth does man kind typically suppress (1:18-19)?

b. The Process of Man's Distortion of the Truth about God. 1:19-23.

- 1) REVELATION. God has clearly revealed Himself to man (1:19). How has He done so (1:20)?
- 2) What can we know about God from nature (1:20)?
- 3) What does Psalm 19:1-6 add to the previous question?
- 4) DISTORTION. Man started by knowing about God (1:21; see also Genesis 1-2).
- 5) What steps did man take in distorting the truth about God (1:21-22)?
- 6) Man foolishly began to worship the Creation rather than the Creator (1:22-23).
 - a) How has this substitute worship typically expressed itself (1:23)?
 - b) How has this substitute worship expressed itself in the religions of Eastern Mysticism (Hinduism, Buddhism, New Age)?

- c) How has this substitute worship typically expressed itself in modern day Science and Education?
- c. JUDGMENT. God's Judgmental Giving Over of Mankind to Evil. 1:24-32. The verdict on the human race is terrible (1:25). When man exchanges the Truth about God for a Lie and chooses to worship and serve the Creation rather than the Creator, God gives mankind over to three terrible judgments.
 - IMPURITY. The first thing to which God gives those who reject Him is lust in their hearts to commit impurity (1:24). (This means moral impurity. See 2 Corinthians 12:21; Galatians 5:19; Colossians 3:5.)
 - a) What effect, from God's point of view, does this have on the human body?
 - b) How has our society's view of fidelity in marriage and of promiscuity changed in the last 100 years?
 - c) To what do you attribute this?
 - 2) **DEGRADING PASSIONS.** The second thing to which God gives those who reject Him is degrading passions (1:26).
 - a) How do the degrading passions reveal themselves in women (1:26)?
 - b) In men (1:27)?
 - c) The text says that those who participate in these degrading passions receive "in their own persons the due penalty of their error." What do you think that means?
 - d) How has our society changed its view of these degrading passions in the last 100 years?
 - e) To what do you attribute this?
